- Clerks: **\$120** Stipend includes compensation for completing Election Day assignment and attending one (1) training class.
- Asst Supervisor: **\$195** Stipend includes compensation for completing Election Day assignment and for attending two (2) training classes.
- Supervisors: **\$235** plus mileage. Stipend includes compensation for completing Election Day assignment and attending two (2) training classes.
- Bilingual: **\$10** additional payment. Paid to workers specifically hired based on bilingual skills and who successfully complete bilingual testing.
- Work Hours: Poll workers are required to report to their assigned polling place at 6:00 a.m. and work the entire Election Day (approximately 9:00 p.m.). County Employees will receive their regular county pay plus the appropriate training and Election Day compensation.
