#### Qualified Nominees Declared Elected to County Central Committees

Not all contests listed on the **Offices Up For Election** appeared on the ballot. In the case of nominees for county central committees, if the number of candidates nominated for election does not exceed the number of candidates to be elected, the contest does not appear on the ballot, and the Board of Supervisors shall declare the nominated candidates elected. The persons nominated in this manner begin their terms and serve in the same manner as if they were elected by the voters of the district.
