### **PUBLIC NOTICE** **Observation Schedule** **November 3, 2020 Presidential General Election**

The public is invited to observe as the San Bernardino County Registrar of Voters conducts a series of public events related to the election. All events will take place at the San Bernardino County Registrar of Voters office according to the following schedule:

- **September 30, 2020** – The logic and accuracy testing of the County’s high-speed ballot scanners and vote tabulation system begins at 10 a.m. and continues on October 1 at 10 a.m., if needed.
- **October 5, 2020** – The processing of mail ballot return envelopes begins at 8 a.m. and is performed daily, Monday through Friday, until the daily workload is complete.\*
- **October 8, 2020** – The processing of mail ballots begins at 8 a.m. and is performed daily, Monday through Friday, until the daily workload is complete.\*
- **October 26, 2020** – The counting of mail ballots begins at 10 a.m. and continues periodically, until the daily workload is complete.\*
- **November 3, 2020**
  - Ballots picked up midday from polling places will begin arriving at the Registrar of Voters office at 1 p.m., and the counting of the ballots will begin shortly thereafter.
  - All other polling place ballots will arrive after the polls close at 8 p.m.
- **November 4, 2020** – The official canvass begins at 8 a.m. and will be completed on or before December 1, 2020.
- **November 5, 2020** – The random precinct selection for the one percent manual tally of the polling place ballots counted on the high-speed ballot scanners takes place at 10:30 a.m.
- **November 11, 2020**
  - The one percent manual tally of the ballots counted on the high-speed ballot scanners begins at 9 a.m. and is performed daily, Monday through Friday, until complete.\*
  - The random batch selection for the one percent manual tally of the mail ballots counted on the high-speed ballot scanners takes place at 2 p.m.

Due to the current public health emergency, the Registrar of Voters may need to limit the number of observers it can accommodate at one time. If a face covering order is in effect, all observers will wear masks. If social distancing would prohibit proper observation, observers will also wear face shields. The Registrar of Voters will have face masks, face shields, and hand sanitizer available.

\*These processes may continue on Saturdays, Sundays, or holidays, depending on the workload. Call for more information about weekend and holiday observation opportunities.
